Tournament Rules:

- Players will start with 20,000 in tournament chips.
- On-Site Registration and unlimited Re-Entries are available until the start of Level 9 of this event. Approximately 5:20pm.
- If player has been eliminated from the tournament, they may Re-Enter the event. Alternates and late sign-ups will enter the tournament with a full chip stack and no obligation from it.
- Levels will last 30 minutes each. Final Table will be 40 minutes. Seating may be limited for this event.
- Dinner Break will be from 8:30pm - 9:10pm
- TDA and House Rules apply. Tournament Directors decisions are final and without recourse.
- Dinner Break will be from 6:30pm - 7:10pm
- or misinformation on the website or printed material pertaining to this event, and players will have no claim in these matters.
- Redraw at 24 and 8 players or at Tournament Directors discretion.
- Winners will be paid in casino chips.
- All tax laws foreign and domestic apply. Winners must show a valid ID to collect winnings. Residents of foreign countries without a U.S. tax treaty will be subject to withholding. Pursuant to IRS regulations, W-2G or 1042 forms will be issued for all tournament winnings of \$5,000 or more (net of buy-in amount)
- Tournament prize pools may be modified if one table remains. All players must unanimously agree.
- \$280 will go into the prize pool. \$60 is withheld for house administrative and staff fee.
- All unredeemed payouts past 90 days of the initial date of the tournament payout, those funds will be surrendered to the Grand Poker Series revenue.
